SUBJECT: Status of Enforcement — Fiscal Year 2018, Second Quarter (1/1/2018 – 3/31/18)

To assist the Commission and the Office of General Counsel in assessing the current productivity of the Commission's enforcement program, we submit the Status of Enforcement for the Second Quarter of Fiscal Year 2018 (1/1/2018 - 3/31/18). The tables that follow provide information to assist agency management in its review of the enforcement program.

In summary, at the close of the quarter the total caseload was 269 — 195 active and 74 inactive. During the quarter, Complaints Examination & Legal Administration ("CELA") circulated 9 EPS reports in an average of 43 days. The Enforcement Division circulated First General Counsel's Reports in 24 matters in an average of 129 days, meeting the internal circulation goal 83% of the time. The Commission completed pre-probable cause conciliation with 12 respondents in an average of 267 days. There were 27 matters pending in the investigation stage at the close of the quarter. The Commission closed 35 matters in an average of 368 days from the receipt of the complaint or referral, with 21 of those matters (60%) closing within 15 months of receipt. The Commission negotiated a total of \$14,500 in civil penalties for all matters that closed during the quarter.
