**SUBJECT:** Status of Enforcement – Fiscal Year 2020, First Quarter (10/1/19-12/31/19)

To assist the Commission and the Office of General Counsel in assessing the current productivity of the Commission's enforcement program, we submit the Status of Enforcement for the First Quarter of Fiscal Year 2020 (10/1/19-12/31/19). The tables that follow provide information to assist agency management in its review of the enforcement program.

In summary, at the close of the quarter, the total caseload was 288 - 233 active and 55 inactive. During the quarter, Complaints Examination & Legal Administration ("CELA") circulated 8 EPS reports in an average of 41 days. The Enforcement Division circulated First General Counsel's Reports in 21 matters in an average of 103 days, meeting the internal circulation goal 86% of the time. The Commission completed pre-probable cause conciliation with 4 respondents in an average of 241 days. There were 43 matters pending in the investigation stage at the close of the quarter. The Commission closed 2 matters in an average of 334 days from the receipt of the complaint or referral and, therefore, met the goal of 15 months for both matters.
