**SUBJECT:** Status of Enforcement – Fiscal Year 2020, Third Quarter (4/1/20-6/30/20)

To assist the Commission and the Office of General Counsel in assessing the current productivity of the Commission's enforcement program, we submit the Status of Enforcement for the Third Quarter of Fiscal Year 2020 (4/1/20-6/30/20). The tables that follow provide information to assist agency management in its review of the enforcement program.

In summary, at the close of the quarter, the total caseload was 366 — 281 active and 85 inactive. During the quarter, Complaints Examination & Legal Administration ("CELA") circulated 6 EPS reports in an average of 69 days. The Enforcement Division circulated First General Counsel's Reports in 24 matters in an average of 165 days, meeting the internal circulation goal 67% of the time. There were 37 matters pending in the investigation stage at the close of the quarter. The Commission closed 7 matters in an average of 854 days, thereby meeting its goal 14% of the time.
