SUBJECT: Status of Enforcement – Fiscal Year 2020, Fourth Quarter (7/1/20-9/30/20)

To assist the Commission and the Office of General Counsel in assessing the current productivity of the Commission's enforcement program, we submit the Status of Enforcement for the Fourth Quarter of Fiscal Year 2020 (7/1/20-9/30/20). The tables that follow provide information to assist agency management in its review of the enforcement program.

The information included reflects a sustained high level of Enforcement activity in FY 2020. In summary, at the close of the quarter, the total caseload was 388 matters — 298 active and 90 inactive. During the fiscal year, Complaints Examination & Legal Administration circulated 24 EPS reports in an average of 58 days. The Enforcement Division circulated 103 FGCRs in an average of 153 days, meeting the internal circulation goal 68% of the time. There were 37 matters pending in the investigation stage at the close of the quarter. The Commission closed 37 matters in an average of 530 days, thereby meeting its goal 62% of the time. The Commission negotiated a total of \$70,200 in civil penalties for all matters that closed during the fiscal year.
