SUBJECT: Status of Enforcement – Fiscal Year 2021, Second Quarter (01/01/21-03/31/21)

To assist the Commission and the Office of General Counsel in assessing the current productivity of the Commission's enforcement program, we submit the Status of Enforcement for the Second Quarter of Fiscal Year 2021 (01/01/21-03/31/21). The tables that follow provide information to assist agency management in its review of the enforcement program.

In summary, at the close of the quarter, the total caseload was 435 matters — 340 active and 95 inactive. During the quarter, the Enforcement Division's Office of Complaints Examination & Legal Administration ("CELA") circulated 3 EPS reports in an average of 56 days. The Enforcement Division also circulated First General Counsel's Reports ("FGCRs") in 23 matters in an average of 207 days, meeting the internal circulation goal 70% of the time. There were 27 matters pending in the investigation stage at the close of the quarter. There were also 43 case closings and the Commission assessed \$168,000 in civil penalties.
