As Mr. Duffy indicated to you, this quote does not appear on Unity08's website now and we have not been able to determine whether it was ever on the website. Indeed, the current "donations" page makes no reference to a potential Unity08 ticket as demonstrated by the attached printout from the current site. Accordingly, please take all the necessary efforts to make this correction.
