Thank you for the opportunity to comment on Google's request referenced as AO 2022-14.

I am strongly opposed to Google's efforts to allow political spam to bypass its otherwise strong spam filters, and urge you to deny the company's request.

Let me start by saying, my email inbox is *not* a public arena.

My Gmail inbox is an essential daily business tool as a self-employed individual. Having to wade through the dozens of SPAM emails I receive every day to mark them manually as the garbage they are, is both an unproductive use of my time and an often maddening exercise.

To quantify the magnitude of the problem for you, I logged one week's worth of SPAM. Please see the summary below. Mercifully, this is currently separated from my legitimate email, but that will no longer be the case for the bulk of these SPAM emails if you approve Google's request.

The political emails I receive are all unsolicited and unwanted. The senders tend to ignore opt-out list and unsubscribe requests. These emails are the exact sort of messages I depend on email spam filters to deal with, so I don't have to waste my time and attention sorting through them. If you allow this, it will set a precedent for other organizations to request similar exemptions. if someone \*wants\* to receive an email from a political entity, that individual can go through the process of white-listing the address - just like Gmail requires for any other mass-email product.

Please, PLEASE deny this request.

- \* This will be free advertising and promotion, constituting illegal contributions.
- \* FREE media advertising is considered a political contribution.
- \* This free advertising will allow even more misrepresentation of facts, which is destroying our political system & country, and will be deceptive and confusing to citizens.
