
Dear Mr. Jordan:

I am the Treasurer for O'Donnell for Congress. I have reviewed the complaint filed by Margaret Yonco-Haines in this matter and respond as follows:

1. Regarding the allegations of unlawful in-kind contributions for our campaign announcement at Mediacom Communications, the candidate paid for the use of the facilities with a check from his personal bank account dated 1/31/18 (See Attachment "A"). We failed to report this in-kind contribution on our April Quarterly Report. We will amend that report to disclose the in-kind contribution;
2. Regarding the allegations of unlawful in-kind contributions for campaign fundraisers held at Dana Distributors on 3/8/18 and Dutchess Manor on 3/25/18, the invoices for these events arrived after the reporting cut-off date for our April Quarterly Report. The Dana Distributors invoice was dated 4/2/18 and paid on 4/23/18 (See Attachment "B"). The Dutchess Manor invoice was dated 4/4/18 and paid on 4/11/18 (See Attachment "C"). These expenditures have been reported on our pre-primary filing of 6/14/18.
3. Regarding the issue of receipts of corporate contributions, please be advised that the \$500 contribution from Maxwell Security Group LLC and the \$500 contribution from Cameo Hills Ltd were both refunded on 5/2/18 (See Attachment "D"). These refunds have been reported on our pre-primary filing for 6/14/18. Please be advised we are also addressing the issues of these corporate refunds with the FEC's Reports Analysis Division.
