### **COMPLAINT**

Complainant files this complaint under 52 U.S. Code § 30121 (a)(1) against an unknown person or entity, for attempting to make a prohibited contribution to the Veronica Vasquez Campaign.

### A. FACTS

- 1. Veronica Vasquez is a candidate for Judge of Probate Court #2 in Bexar County, Texas in an election to be held on November 6, 2018.
- 2. On May 18, 2018, an unknown person attempted to contribute to the Veronica Vasquez Campaign two (2) online contributions from an unknown source which appeared to originate from a foreign country. The first attempted contribution was for \$1.00, and the second was for \$25.00 (see attached).
- 3. The person or entity attempting to make the contribution used a pre-paid MasterCard, and did not provide a name or address on the donation form as required.
- 4. The complainant immediately cancelled the contributions through the payment processor, Stripe.
- 5. A representative of the Veronica Vasquez Campaign contacted the Texas Ethics Commission (TEC) to report the incident. The TEC recommended that the Federal Elections Commission be contacted in this matter.

### **B. CONCLUSION**

1. The Federal Election Commission should investigate these attempted foreign contributions to determine the extent of interference in the election.




