COMPLAINT

Complainant files this complaint under 52 U.S. Code § 30121 (a)(1) against an unknown person or entity, for attempting to make a prohibited contribution to the Joe Gonzales Campaign.

A. FACTS

- 1. Joe Gonzales is a candidate for District Attorney of Bexar County in an election to be held on November 6, 2018.
- 2. On July 7, 2018, an unknown person attempted to contribute to the Joe Gonzales Campaign one (1) online contribution from an unknown source which appeared to originate from a foreign country. The attempted contribution was for \$1.00.
- 3. The person or entity attempting to make the contribution used a pre-paid MasterCard, and did not provide a name or address on the donation form as required.
- 4. The complainant immediately cancelled the contribution through the payment processor, Stripe.
- 5. A representative of the Joe Gonzales Campaign contacted the Texas Ethics Commission (TEC) to report the incident. The TEC recommended that the Federal Elections Commission be contacted in this matter.

B. CONCLUSION

1. The Federal Election Commission should investigate these attempted foreign contributions to determine the extent of interference in the election.


