COMPLAINT

This Complaint raises some possible campaign reporting violations of Form 3 filings by the AJ Kern for Congress committee (the "Committee") for unitemized contributions in excess of \$200 from a single donor, failure to report expenses, and improper disclosure of expenses.

ISSUE I UNITEMIZED CONTRIBUTIONS EXCEEDING \$200 FROM A SINGLE DONOR

1. The original April Quarterly 2016, July Quarterly 2016 and Pre-Primary 2016 Reports disclosed several contributions from John Kern, which aggregated to \$1,170.00. However, none of these contributions (detailed below) appears on the respective amended Reports. These contributions violate the reporting requirements set forth in 11 C.F.R. § 104.3(a).

2. On the October Quarterly 2016 Report, there are \$1,456 of unitemized donations reported, raising the possibility of more contributions from John Kern in excess of the \$200 aggregate.

ISSUE II OMISSION OF CAMPAIGN ADVERTISING EXPENSES

- 1. On October 11, 2017 and November 23, 2017, the "AJ Kern MN 6th District" Facebook Page, with the URL of www.facebook.com/AJKernforCongress, sponsored posts with a media appearance to promote her candidacy and information about her opponent's record, respectively. Screenshots of both sponsored ads are attached.
- 2. On the Year End 2017 report, there are neither cash nor in-kind expenses reported for the fourth quarter of 2017. These expenses violate the reporting requirements set forth in 11 C.F.R. § 104.3(b).

ISSUE III OMISSION OF CAMPAIGN ADVERTISING EXPENSES

On the July Quarterly 2018 report, none of the itemized expenditures is associated with a purpose for the expenditure. These expenses violate the reporting requirements set forth in 11 C.F.R. § 104.3(b).




