On behalf of respondents For Our Future and Sky Gallegos, in her official capacity as Treasurer ("Respondents"), for the following reasons we request a 30-day enlargement of time from January 23 to February 22 to respond to your letter dated January 5 informing Respondents of a referral to the Office of General Counsel, which the Respondents received on January 8.

The referral concerns a substantial number of transactions totaling several million dollars during three reporting periods in 2016. Although we have previously corresponded with the Reports Analysis Division concerning these (and other) transactions, in the current posture of the matter we are further examining our records so that we can submit a thorough response. We cannot complete this review and submission over the next few days.

Meanwhile, undersigned counsel are occupied with other litigation and matters, unavoidable scheduled travel (including this coming week), and a major scheduled family medical procedure involving one of the undersigned.

The brief requested enlargement of time will have no practical bearing on the operation of the statute of limitations in this matter, as the referral concerns events occurring since October 2016.
