RESPONSE

Through counsel, Mike Braun, Mike Braun for Indiana, and Travis Kabrick, in his official capacity as Treasurer, (collectively, "the Respondents") provide the following response to the complaint filed with the Federal Election Commission ("FEC" or "Commission") by the Indiana Democratic Party ("Complainant") and designated by the Commission as MUR 7490.

This complaint arises out of the Respondents' lawful transmission of a required 48-Hour Notice of Contributions Received report ("the Report"). Upon closer review, it is clear the Respondents satisfied their obligations under the Federal Election Campaign Act of 1971, as amended ("FECA" or "the Act"), including all disclosure requirements therein. In summary, it appears the Report, though properly prepared and adequately transmitted in accordance with all requirements of the Act, did not fully transmit to the Senate Office of Public Records as a result of an unforeseen technological failure beyond the control of the Respondents. Therefore, because the Respondents met their responsibilities under the Act and have since fully disclosed all transactions provided in the Report, the Commission should use its sound judgement to quickly dispose of this complaint and close this matter without further action.

I. BACKGROUND

Mike Braun is currently a candidate for the United States Senate from Indiana, and Mike Braun for Indiana is Mr. Braun's authorized candidate committee. On April 23, 2018, Mike Braun made several permissible transfers to Mike Braun for Indiana, including a \$250,000 loan to Mike Braun for Indiana ("the Loan"). Consistent with the Act and FEC regulations, Mike Braun for Indiana prepared the Report itemizing the Loan and disclosing all required transaction details. A copy of the Report, as prepared, is attached hereto as Exhibit A.

On April 25, 2018, Mike Braun for Indiana transmitted the Report to the Senate Office of Public Records via facsimile and received confirmation that the Report was transmitted successfully. A copy of that confirmation is attached hereto as Exhibit B. Subsequent to filing the Report, Mike Braun for Indiana also disclosed the Loan on its next regular disclosure filing. During transmission of the Report and unbeknownst to the Respondents, certain, but not all, details of the Loan became illegible or otherwise damaged. Prior to this complaint, the Respondents were not notified by either the Senate Office of Public Records or the Commission that the Report, as received, was damaged or otherwise contained illegible elements. ²

II. ANALYSIS

The Respondents properly transmitted the Report to the required filing authority within the timeline of disclosure mandated by the Commission's rules; however, the Respondents acknowledge that during the transmission process, certain elements of the Report became damaged or otherwise illegible. A review of the attached exhibits makes clear that the Respondents intended to fully disclose all transactions, including the Loan.

Indeed, although it is damaged, the Report as received shows the Loan occurred and that Respondents intended to disclose that Loan. Only the amount of the Loan became illegible. The Respondents' disclosure of the Loan on the next regular disclosure report also demonstrates that the Respondents had no intention of withholding the existence of the Loan or any of its details. Furthermore, at no point did the Respondents receive notice from any responsible filing authority that the submitted Report contained damaged or illegible data. Had the Respondents received such notice, the Respondents willingly would have taken prompt action to refile the Report.

In summary, the Respondents accurately and completely satisfied their disclosure obligations under the Act and FEC regulations, and they should not be held responsible for either (i) an unforeseen and uncontrollable technological error or (ii) the failure of the responsible filing authorities to notify the Respondents that their filing had been damaged during transmission.

III. CONCLUSION

As described above, Respondents have fully complied with the Act and FEC regulations. Thus, the Commission should find no reason to believe that a violation has occurred in relation to the facts presented.
