#### To Whom This Concerns,

First, I apologize for this late response to the FEC complaint, MUR #7529 by Eliot J. Rabin, the candidate of the Eliot Rabin for Congress Campaign.

A letter dated Oct. 31, 2018, was sent to 11238.

., Brooklyn, NY

I had moved from that address Sept. 1, 2018. I received this letter at my current address Feb. 11, 2019, which is Brooklyn, NY 11205.

I resigned from the campaign August 18, 2018, as a result of poor management and persistent patronization by the candidate.

Regarding the accusations levied by the Rabin campaign - I submit the following:

I firmly deny these accusations. I do not recall withdrawing any cash using my campaign card, and the only purchase related to the complaint I made during my brief tenure on the campaign was for sunscreen to ensure to candidate did not burn while palm carding.

- 1. I was not terminated. I sent a letter of resignation, effective immediately, to Eliot Rabin August 18, 2018. I quit the campaign due to purposeful mismanagement by Mr. Eliot J. Rabin, himself.
- 2. Neither the withdrawal nor the purchase are typical of my buying behavior. Furthermore, I formally request the bank serving the Eliot J. Rabin Campaign be subpoenaed for copies of the records showing signatures and videotape from the ATM or branch showing the withdrawal, as it is more than likely the candidate misappropriated funds and is looking to shift responsibility.
- 3. Additionally, I'm attaching copies of the invoices that were agreed to by the Rabin Campaign during my tenure as the campaign manager, which neither Mr. Rabin nor his treasurer-turned-campaign manager Mr. Bryan Jung were willing to satisfy. These still-unpaid invoices total \$13,400.

If we are raising FEC issues, Mr. Rabin is not only liable for breach of contract, per New York State verbal contract law, he is also in violation of New York City law regarding failure to pay independent contractors.

I would appreciate if you could aid in remedying both the investigation into these outrageous claims, as well as the numerous violations of New York City and New York State laws by the Eliot Rabin for Congress Campaign.

Please let me know how I may best assist you in furthering this investigation.
