

Re: MUR 7534 – Request for Extension

Dear Mr. Jordan:

This requests an extension of time to respond to the letter from the Federal Election Commission informing our clients, Congressman Bill Huizenga, Natalie Huizenga, and Huizenga for Congress and David Nienhuis in his official capacity as Treasurer, of a complaint filed against them in the above-referenced matter. Respondents received their notification letters on November 19, 2018, and their response is currently due December 4, 2018. The Designation of Counsel forms are attached.

We respectfully request an extension of an additional 45 days, or until January 18, 2018, to respond to the complaint. We understand that 45 days is a lengthy request, but we believe it is necessary for a number of reasons. First, much of that period will fall during the holiday season, when businesses may be closed and individuals will be traveling. Second, the allegations in the complaint require the gathering and analysis of records related to thousands of financial transactions, some that date back to at least 2014. Indeed, the complaint contains over 100 pages of exhibits containing line-item transactions about which we will have to gather information to rebut the allegations in the complaint. For these reasons, we believe a 45-day extension will be necessary to permit us to properly evaluate the allegations, research and compile necessary documentation, and ensure a complete and accurate response.
