Tea Party Majority Fund response to AR 17-07R

The Federal Election Commission has ascertained information in the normal course of carrying out its supervisory responsibilities that indicate the committee may have violated the Federal Election Campaign Act of 1971, as amended. This is the committee's response to the issues raised by the Commission's review.

1. 2016 2nd Quarter Report: Schedule B supporting Line 23 disclosed contributions designated for the primary election of one (1) federal candidate totaling \$4,000.00, or 88.9% of the total federal contributions. This contribution was dated after the respective election.

The committee made an In-Kind primary election contribution to Stephen MacKenzie for Congress (C00609735) after the date of the Indiana Primary Election. This payment was made to a mailing firm used by Stephen MacKenzie for a pre-primary mailing. Therefore, it was a debt retirement contribution and the vendor in question was: Acculink, 1055 Greenville Blvd SW, Greenville, NC 27834.

2. 2016 1st Quarter Report: Schedule E disclosed calendar year-to-date per election for office sought discrepancies totaling \$353,273.16 for independent expenditures made.

The committee reported Schedule E, Line 24 disbursements opposing Hillary Clinton for President on the 1st Quarter 2016 FEC Disclosure Report. There were three (3) expenditures totaling \$ 353,273.16 and each was allocated to the fifty (50) states and the District of Columbia using the Voting Age Population (VAP).

The committee has reviewed the calendar year-to-date per election totals and there does NOT appear to be any discrepancies. The table that follows shows the amounts disbursed allocated by state and the subtotals for each state appear to be correct as they agree with the amounts reported.

3. 2015 Mid-Year Report: The Committee failed to timely file a required 48-Hour Report for \$200,000.00 in independent expenditures disclosed on Schedule E.

The committee filed a 48-Hour Report (Attachment "A") disclosing \$200,000 for Voter Contact Calls made by InfoCision Management Corporation. The calls were to be made beginning June 1, 2015 and continuing over the course of several weeks; thereby requiring the committee to file Form 24 on or before midnight, June 3rd.

Due to a slow upload, the report was not accepted by the FEC until June 4, 2015 – 00:01:20 (Attachment "B"); a full minute and twenty seconds past midnight. The committee believes it has satisfied the spirit of the Act and the tardiness of the filing should be disregarded.

4. 2016 1st Quarter Report: Schedule E disclosed memo entries for fifty-one (51) independent expenditures totaling \$400,000.00, which were publicly disseminated prior to payment but failed to disclose a debt on Schedule D. The Committee failed to file a required 48- Hour Report for \$353,273.16 in independent expenditures disclosed on Schedule E.

The 1st Quarter 2016 FEC Disclosure Report filed by the Tea Party Majority Fund disclosed memo entries for fifty-one (51) independent expenditures totaling \$400,000 and in the same reporting period, reported three (3) disbursements equaling \$353,273.16 related to those memo entries. Therefore, there is no requirement to file Form 24 for the \$353,273.16 as they have already been reported.

In a later amended 1st Quarter 2016 FEC Disclosure Report, the committee reported a debt on Schedule D for \$46,726.84 (\$400,000.00 - \$353,273.16).

5. 2016 2nd Quarter Report: The Committee failed to timely file a required 48-Hour Report for \$15,000.00 in independent expenditures disclosed on Schedule E.

It appears that a 48-Hour Report for \$15,000 in independent expenditures disclosed on Schedule E for Rapid Response Television Ads to be run on March 28, 2016 and dates thereafter was required to be filed on or before March 30th and was not filed until April 30th.

6. 2016 3rd Quarter Report: Schedule E disclosed a memo entry for one (1) independent expenditure totaling \$450,000.00, which was publicly disseminated prior to payment but failed to disclose a debt on Schedule D. The Committee failed to file a required 48-Hour Report for \$393,569:24 in independent expenditures disclosed on Schedule E.

The 3rd Quarter 2016 FEC Disclosure Report filed by the Tea Party Majority Fund disclosed a memo entry for independent expenditures totaling \$450,000 and in the same reporting period, reported seven (7) disbursements equaling \$393,569.24 related to that memo entry. Therefore, there is no requirement to file Form 24 for the \$393,569.24 as they have already been reported.

In a later amended 3rd Quarter 2016 FEC Disclosure Report, the committee reported a debt on Schedule D for \$56,430.76 (\$450,000.00 - \$393,569.24).

7. 2016 Amended 12G Report: Schedule E disclosed a memo entry for one (1) independent expenditure totaling \$212,943.72, which was publicly disseminated prior to payment but failed to disclose a debt on Schedule D.

The memo entry for one (1) independent expenditure totaling \$212,943.72 reported on the Amended 12G FEC Disclosure Report is an amended figure. The original budgeted amount reported was \$450,000; however, the number was reduced to reflect the actual spending figures. As such, no debt was required to be reported on Schedule D.

8. 2015 Mid-Year Report: Schedule A supporting Line 11(a)(i) failed to disclose adequate identification for 47 of 113, or 41.6%, of the contributions from individuals that require itemization.

The committee amended the Mid-Year 2015 FEC Report and provided Employer and Occupation information on all but three (3) donors. This would mean that the committee has provided adequate identification for 97.3% of the contributions from individuals.

SUMMARY

Based on the committee's response to the issues raised by the Commission, it is the position of Tea Party Majority Fund that the committee has acted in good faith and used best efforts to comply with the Act and Federal Regulations and that no further action should be taken by the Commission.

This response is directed to the General Counsel's Office and is submitted under oath.
