The purpose of this communication is to file a formal complaint against Team Gayot, the above mentioned campaign committee.

Team Gayot, the candidate and treasurer have violated FEC Law. They did so by failing to report outstanding liabilities owed to:

I am saddened to see a campaign committee violate FEC Law and deny voters our Right to know what the campaign has actually spent.

I do not want the campaign to have my address and respectfully request that my name and information be redacted from any communication with the campaign.


