To Whom It May Concern:

I would like to report several violations from TOM NORTON FOR CONGRESS (ID: C00704270) CAMPAIGN. There are several invoices that Scale Campaign sent to the campaign that were not logged, not reported and not paid.

I was Campaign manager for the campaign from the very beginning, including the exploratory committee time - from April 4 2019 until June 11 2019.

As was very clear to everyone on the campaign, including Mr. Thomas Norton that I will not work for free and have to be paid for my work. Also some third party vendors services paid by Scale Campaign were not logged and reported.



During the period as Campaign manager I had to deal with another similar issue where the legal counsel to the campaign had sent two invoices each \$3000 to be logged and paid. From the public listings as of today those are not logged either:

To the best of my knowledge Mr. Norton ignored those for long time and later got involved into some negotiations with the already former legal counsel.
